OSG Midwestern Production Facility Moves to New Site

More than Twice the Size of the Former Facility

Backup facilities not only provide security through redundancy, but assist in expediting mail delivery through multiple locations.

According to John Springthorpe, III, OSG President and COO, "The new space in Wisconsin is over twice the size of our former production facility. Our continued growth was ample reason for the expansion of our Wisconsin plant. We'll be outfitting the facility with new equipment and an upgraded network. The new space, added size and new projects will enhance our abilities to provide integrated multi-channel electronic and print and mail solutions through a highly-controlled, state-of-the-art processing environment. This, in turn, will allow us to continue providing our customers with the highest level of service." While this is good news for OSG it is also good news for the greater Milwaukee community. The company plans to hire additional staff to keep up with the increased workload.
